# Would you like to privatize L'Altitude for an event? Here is all the practical information!

First, we thank you for considering us to host your event. Due to the high number of requests, we can unfortunately only accept a limited number of privatizations.

Below are the conditions that apply to all privatizations.

#### General information:

- You have access to the interior of the restaurant from 5:00 pm to 12:30 am, while the terrace remains accessible to the public and cannot be privatized. The capacity of our establishment is a maximum of 35 people. For safety and service management reasons, we cannot accept more people.
- We understand the excitement that a good party can bring, but we ask you to
  always remain respectful towards other customers, our team, and the neighbors.
  If any disturbances are observed, we reserve the right to immediately end the
  event. A fee of 2500 euros will then be due by the person who made the
  reservation.
- The DJ space is strictly prohibited during the event except for the person(s)
  responsible for the music. This person must be designated to us before the event.
  Otherwise, we will consider that no one, except our employees, is authorized to
  use the sound system.
- Any damage to the sound system or its components (amplifiers, preamplifiers, turntables, mixer, speakers, streaming system, computer, etc) will be fully charged to the person who privatized the space. A flat fee of 4000 euros will be due immediately (in addition to the cost of privatization). This amount may be increased after receiving the repair estimate.
- Any total loss will result in a compensation request equivalent to the production or purchase price of the damaged item(s) as of the date of the damage.
- The consumption of drugs on the premises is strictly prohibited.

### Food and drinks:

- The menu will be composed by the chef based on the monthly menu. All our dishes are for sharing and will be served progressively, with the meal starting between 8:00 pm and 8:30 pm.
- We recommend having a prior discussion to define in advance which drinks will be covered or not by the person organizing the privatization.

### Fees and payment:

- We do not charge privatization fees. However, the final bill must reach a minimum of 2500 euros. Otherwise, you will need to pay the difference to reach that amount. If you exceed the 2500 euros amount, you simply pay the final bill
- For obvious organizational reasons, it is not possible to split the bill. It is the responsibility of the person organizing the privatization to pay the entire bill on the same day.

- Make a bank transfer of 500 euros to the account BE97 0018 9305 6949 with your name, the word "privatization", and the date of the event in the payment description
- Any cancellation within the 15 days preceding the scheduled date will result in the deduction of the deposit as compensation.
